The Rush To A Cashless Society Only Serves Globalist Interests

A fundamental pillar of true free markets is the existence of choice; the availability of options from production to providers to purchase mechanisms without interference from governments or corporate monopolies. Choice means competition, and competition drives progress. Choice can also drive changes within society, for if people know a better or more secure way of doing things exists, why would anyone want to stay trapped within the confines of a limited system? At the very least, people should be allowed to choose economic mechanisms that work best for their particular situation.

This is NOT how our society functions today, and free market do not exist anywhere in modern nations including the US. Whenever I hear someone (usually a socialist) blame free market “capitalism” for the oppressive ailments of the world, I have to laugh. The alliance between governments and corporate monopolies (what Mussolini called national socialism or fascism) makes free markets utterly impossible. What we have today is an amalgamation of socialist economic interference and corporatocracy. Our system is highly restrictive and micro-managed for everyone except the money elites, who do not have to follow the same rules the rest of us do.

Of course, I might be preaching to the choir when it comes to these issues. But, there are some underlying developments being pushed forward by globalists hell-bent on a one world monetary system and a one world government that even many liberty activists are not fully aware of.

In alternative economic circles, the US dollar is seen as the end-all-be-all of fiat currency dominance. Many activists see it as the key to the power of the global elites and they think the Federal Reserve is the top of the globalist pyramid. This is not exactly true.

The US dollar is itself just another tool of the banking cabal, and tools sometimes lose their usefulness over time. While it could be said that for the past several decades the dollar as the world reserve currency was the core of globalist influence, this is about to change and we can see the signs today. The rush towards a cashless society in the past few years is startling and unfortunately too many liberty activists have been suckered into thinking that it's is a good thing.

There are a number of reasons for this. As mentioned above, activists see the dollar (or Fed note) as fuel for the globalist machine, and so obviously they would like to see it go down in flames. They also are generally proponents of free markets, and the exploding trend of cryptocurrencies has given them the illusion that “choice” is returning to economy through “monetary competition”. I understand the basis

for this attitude, and I appreciate where it's coming from. I also have never been a proponent of the dollar or any other central bank fiat system. This article should not be misinterpreted as a defense of dollar hegemony.

That said, there is a much bigger agenda at play here, and the dollar is only one fading part of it as it is being quietly replaced by a completely digital framework. We have to once again ask ourselves – Who really benefits from a sudden shift in the economic and monetary world? Who gains political and social power through a cashless society? Is it the public? Or, is it the same banking elites and globalists that have always held sway over our economic structure?

In 2017 I published an article called 'The Globalist One World Currency Will Look A Lot Like Bitcoin'. In it, I warned that the trendy marketing of cryptocurrencies to the general public by the mainstream media was extremely suspicious and contrary to the notion that the establishment was "terrified" of Bitcoin or blockchain tech putting them out of business. I also warned of the deep involvement of international banks like Goldman Sachs and JP Morgan in the progress of blockchain infrastructure and more specifically Goldman Sachs and the IMF's love affair with digital monetary systems. Goldman Sachs even referred to the blockchain as "the new technology of trust..."

Clearly, the banking elites are not worried about this technology. In fact, they have been investing in it heavily. But why? I have long held that current popular cryptocurrencies are nothing more than a beta test for a global digital currency system controlled by the elites.

This is not to say that many people are familiar with using Bitcoin or other cryptocurrencies. In fact, only a tiny percentage of the population ever comes into contact with or trades crypto. What I am saying is, the terminology, the idea of cryptocurrencies, is now widespread.

Thanks to a vast amount of media attention, Bitcoin is a household brand even though most people have never owned a bitcoin (or a portion of a bitcoin). Whale investors have hyperinflated the price of Bitcoin and certain other coins to levels beyond all reason as demand by the investment world and average people for the mechanism is minimal at best. These price explosions, though brief, have spurred public curiosity. And, in the minds of many if something is considered valuable, no matter how ethereal or arbitrary the measure, there must be a reason...right? Therefore, in the minds of bitcoin cheerleaders high market prices prove by default that Bitcoin and cryptocurrencies are necessary and desirable and anyone who is critical or skeptical is merely "upset" that they "missed out on the opportunity".

I have always said when asked about my position on Bitcoin and crypto that if you want to try to make money on one of these coins and think you can play the market, then by all means, the more power to you. But, for those who thought that cryptocurrencies are a tool for activism and fighting the central banks, all I can say is you have been duped.

Over the course of a decade, the masses have been acclimated to the idea of a digital currency system. They are now being acclimated to the idea that physical currencies should be done away with and replaced with the "more efficient" blockchain tech – Death to the dollar, death to the Fed and death to the globalists say activists as they cheer for the new digital landscape! But this is not what is really happening. The death of the dollar and physical cash is only the primer for a new and even more invasive world order.

In the past two years the agenda for a cashless system and a one world currency has gone mainstream. The plans that liberty analysts were once called "conspiracy theorists" for talking about ten years ago are now out in the open. The latest barrage of propaganda was launched by the governor of the Bank Of England, Mark Carney, who openly warned of the end of the dollar's world reserve status, comparing it to the end of the Pound Sterling's reserve status after WWII. He also noted that the dollar could be

replaced by a new digital currency system and that this would be advantageous the banking system.

This piggybacks on comments made by globalist and PIMCO CEO Mohamed El-Erian in 2017, who stated in an op-ed that the IMF's Special Drawing Rights basket system could be used to replace the dollar as world reserve and that this would help to "fight the rise of populism".

Next, Facebook introduced the concept of the "Libra" digital currency, which Mark Carney also suggested central banks would be watching closely. Libra, in my view, is a test designed to lure wider public into using digital currency on a regular basis. As noted, Bitcoin and other cryptocurrencies gained exposure but not preference. Where they failed to infiltrate the daily trade of the average citizen, Libra could eventually succeed.

So far I think the reaction is not what the globalists hoped for. Instead, Facebook is taking it slowly by introducing a new internal payment system called "Facebook Pay" similar to Paypal. Libra, or something like it, will likely make a reappearance in the next couple of years on Facebook and on other platforms. Next, former ECB chief Jean-Claude Trichet argued in favor of a digital version of the SDR basket system at the Caixin conference in Beijing, arguing that Bitcoin and other cryptocurrencies were not stable enough or "legitimate" enough to take on the role of central bank currencies. Many argue that this is proof that the globalists are afraid of cryptocurrencies. On the contrary, I see this as yet another example of the ongoing fake battle between bankers and crypto. They criticize certain aspects of the technology while at the same time investing in it and promoting it. Like the false left/right paradigm, there is a kind of false central bank/crypto paradigm as well.

Wycliffe, YWAM, & Other Evangelical Groups to Take Part in Roman Catholic-Endorsed Global Event in 2020

Promoters include over 500 leaders and organizations from 200 countries, YWAM, American Bible Society, Wycliffe Bible Translators, the World Evangelical Alliance and Call2All. Many other Bible translation and missionary groups from around the world are involved. One should read the entire article to get the full scope; it is staggering. And groups like PULSE and others who stage enormous gatherings of youth are also involved. The piece de resistance, however, comes at the end of the article which

states that the entire endeavor is being heartily endorsed by Pope Francis in a recorded video from the Vatican.

We are seeing it folks, the one-world religion, not only forming, but gaining momentum and almost at the point of culmination. I do not know how any Bible-believing Christian can be in agreement with such a clearly ecumenical agenda. The Pope will very likely be the head of the false church described in Revelation. He is not “officially, visibly” that yet, but it is there, just waiting in the wings. The 2020 Global Year of the Bible website is registered with the University of the Nations in Hawaii. Loren Cunningham (YWAM’s leader) is the International Chancellor of that school. Bishop Efraim Tendero, Secretary-General of the World Evangelical Alliance (WEA), today launched a global campaign to mark 2020 as the “Year of the Bible”. Founded in 1846, the WEA represents over 600 million Christians worldwide with national alliances in 130 nations.

Projected to be one of the most collaborative movements in Christian history, the Year of the Bible is also supported by His Holiness Pope Francis of the Catholic church, the global Lausanne network, Youth With A Mission, the United Bible Societies, The Seed Company, Biblica and many more.

The year-long initiative is expected to achieve the greatest global Bible engagement in history, as billions follow a call to read the Bible and engage in a global conversation on its message. (emphasis added) Lighthouse Trails can’t help be nervous about this “global conversation” with which “billions” might be involved. If organizations like YWAM and the Roman Catholic Church are instigators of this global conversation with billions, then we can easily speculate what this conversation will look like given that YWAM and the Catholic Church are leaders in promoting the interspiritual, panentheistic contemplative prayer movement (not to mention YWAM’s “new missiology” views that often leaves the Gospel out of missions and the Catholic Church’s overwhelming emphasis on the Eucharist that re-crucifies Christ at every Mass). All the while, Christian leaders either stand by passively and silently or join in helping to bring about a global “revival.”

A Whole Lot Of Shaking Going On: Mt Rainier & New Madrid Fault

Mt. Rainier and the New Madrid fault zone are both shaking, and a catastrophic seismic event at either location would cause death and destruction on an unimaginable scale.

Mt. Rainier in Washington State has been called "one of the most dangerous volcanoes in the world", and scientists tell us that it is just a matter of time before a major eruption occurs.

When that day finally arrives, Mt. Rainier has the potential to bury hundreds of square miles with a colossal tsunami of super-heated mud that is literally several hundred feet deep. And since Mt. Rainier is very close to major population centers, we are talking about the potential for the worst disaster that we have seen in modern American history.

But a massive earthquake along the New Madrid fault zone actually has the potential to be far worse. A very deep scar under the ground that was created when North America was originally formed has made that part of the country very mechanically weak, and many experts believe that a big enough earthquake along that fault zone could literally rip the United States in half.

But before we discuss the New Madrid fault zone, let's talk about what just happened at Mt. Rainier first.

According to the USGS, Mt. Rainier was hit by a magnitude 3.6 earthquake on Sunday afternoon...

After a spurt of seismic activity this weekend, Mount Rainier National Park was shaken by a 3.6 magnitude earthquake Sunday afternoon.

The quake hit at 12:31 p.m. and was felt as far as Kent, WA nearly 80 miles away, the U.S. Geological Survey reported. The relatively shallow quake was centered roughly a mile beneath the earth's surface.

In addition to that quake, there have been quite a few others in recent days.

In fact, it is being reported that Mt. Rainier has been hit by "more than a dozen" earthquakes since Thanksgiving day.

The Seattle Times is assuring us that this is perfectly normal, but they are also warning their readers that they "should prepare for what might happen in the event of an eruption" just in case...

Regardless, people living near Mount Rainier should prepare for what might happen in the event of an eruption, said Wes Thelen, a research seismologist at the Cascade Volcano Observatory. Specifically, an eruption could cause lahars -- large volcanic mudflows -- to rip down the side of the mountain.

Many of my readers clearly remember the eruption of Mount St. Helens in 1980, but a catastrophic eruption of Mt. Rainier would be so much worse that the two events would not even be worth comparing. The following comes from Wikipedia...

If Mt. Rainier were to erupt as powerfully as Mount St. Helens did in its May 18, 1980 eruption, the effect would be cumulatively greater, because of the far more massive amounts of glacial ice locked on the volcano compared to Mount St. Helens, the vastly more heavily populated areas surrounding Rainier, and the simple fact that Mt Rainier is a much bigger volcano, almost twice the size of St. Helens. Lahars from Rainier pose the most risk to life and property, as many communities lie atop older lahar deposits.

According to the United States Geological Survey (USGS), about 150,000 people live on top of old lahar deposits of Rainier. Not only is there much ice atop the volcano, the volcano is also slowly being weakened by hydrothermal activity.

According to Geoff Clayton, a geologist with a Washington State Geology firm, RH2 Engineering, a repeat of the 5000-year-old Osceola Mudflow would destroy Enumclaw, Orting, Kent, Auburn, Puyallup, Sumner and all of Renton. Such a mudflow might also reach down the Duwamish estuary and destroy parts of downtown Seattle, and cause tsunami in Puget Sound and Lake Washington. Rainier is also capable of producing pyroclastic flows and expelling lava.

A lahar is essentially a giant tsunami of super-heated mud, and they can be hundreds of feet high. If you live in that region, you might be thinking that you will just outrun any lahar that is headed your way, but the truth is that the highways will instantly be jammed once an eruption happens and a lahar can travel at speeds of up to 50 miles per hour. The following is how one author described the danger that those living in the area could potentially be facing...

The numerous towns and cities that occupy the surrounding valley would all be at risk for not only severe destruction, but complete annihilation. Residents of cities like Orting, Sumner, Buckley, and Enumclaw are estimated to have no more than 30 minutes before the lahar, speeding down from the many rivers that flow from Mount Rainier, buries their homes and businesses beneath as much as 30 feet of mud and debris.

Even the larger cities like Auburn, Puyallup, and Tacoma itself are not safe. Auburn and Puyallup, with nearly 80,000 residents between them, would be covered in 20 feet of mud in less than an hour, and Tacoma, at almost 200,000, is estimated to be hit with nearly 10 feet from the lahar.

As you can see, the death and destruction would be off the charts, and let us hope that such a disaster does not arrive any time soon.

And as I mentioned earlier, a major earthquake along the New Madrid fault zone has the potential to create even greater death and destruction.

According to scientists, the New Madrid fault zone sits directly above a very deep geological scar that was created when North America was formed. According to Wikipedia, this immense scar makes "the Earth's crust in the New Madrid area mechanically weaker than much of the rest of North America".

Today, the New Madrid fault zone is approximately six times bigger than the San Andreas fault zone in California. It covers portions of Illinois, Indiana, Ohio, Missouri, Arkansas, Kentucky, Tennessee and Mississippi, and the largest earthquakes in the lower 48 states have happened in this region.

Scientists assure us that it is just a matter of time before more catastrophic earthquakes hit this fault zone, and that is why what has been happening near the town of Ridgely, Tennessee in recent days is so concerning...

A swarm of at least 15 earthquakes reaching up to 2.1 magnitude rattled Ridgely, Tennessee -- a small town near the Mississippi River -- over a two-day period, the U.S. Geological Survey reports.

The other quakes in the swarm ranged from 1.1 to 1.5 magnitude, according to the USGS.

Most Americans have never heard of Ridgely, and it is definitely a very small town, but what makes this so important is that Ridgely sits directly inside the New Madrid fault zone...

Ridgely is home to just 1,657 people, according to the U.S. Census Bureau, and sits less than four miles from the banks of the Mississippi River.

It's also part of the New Madrid Seismic Zone -- which the Missouri Department of Natural Resources refers to as "the most active seismic area in the United States, east of the Rocky Mountains."

In 1811 and 1812, four absolutely massive earthquakes along the New Madrid fault zone opened up very deep fissures in the ground, they caused the Mississippi River to actually run backwards in certain places, and they were reportedly felt as far away as Washington D.C. and Boston.

Fortunately, very few people populated the region in those days, but if such a quake happened today the death and destruction would be unimaginable. The following description of one of the quakes that happened in 1811 comes from Smithsonian.com, and for a moment I would like for you to imagine what would happen if such an earthquake happened in our time...

The Midwest was sparsely populated, and deaths were few. But 8-year-old Godfrey Lesieur saw the ground "rolling in waves." Michael Braunm observed the river suddenly rise up "like a great loaf of bread to the height of many feet." Sections of riverbed below the Mississippi rose so high that part of the river ran backward. Thousands of fissures ripped open fields, and geysers burst from the earth, spewing sand, water, mud and coal high into the air.

The New Madrid fault zone has altered the course of the Mississippi River before, and someday it will happen again.

We live at a time when our planet appears to be getting increasingly unstable. In addition to the other earthquakes that I have already mentioned, Alaska was actually hit by a magnitude 6.0 earthquake on Monday.

Unfortunately, most Americans are not going to start caring about the warning signs until a major disaster has already happened.

Most people will simply not wake up without a major amount of shaking, and let us hope that such a day can be put off for as long as possible.
