The WEF and WHO – Running a Death Cult?

A WHO / Pharma-controlled worldwide tyrannical “health system”

From the looks and evidence – ever more visible to even the ignorant – we are living in a Death Cult – a cabal-driven death cult, with a key objective to do away with: eliminate a large segment, if not the majority of the world population.

Who is executing this Death Cult? And on behalf of whom?

Three entities come to mind.

1. The World Economic Forum (WEF)

– a Cologny (lush suburb of Geneva, Switzerland)-registered NGO; a never-voted-for “influencer” organization that has amassed power and money in the hundreds of millions of dollars, like no other NGO around the world. Its founder and eternal chairman, **Klaus Schwab** (84), is an engineer cum economist, with origins linked to the former Third Reich Nazi-leadership.

By the way, the WEF is holding their annual Davos conference from 16-20 January 2023. The pathology of this outfit and of those elitist billionaires and corporate honchos attending is reflected in this year’s even more dystopian agenda. Have a look at the official program.

This is only the visible agenda. None of us, the commons, knows what’s going on behind closed doors in special secretive sessions. We feed on leakages, and they become ever more abundant.

2. The World Health Organization (WHO)

– goes as a specialized UN Agency – which in reality it isn’t. It was founded in 1948 by Rockefeller, a eugenicist and obsessed globalist, who was (and still is) aiming at controlling the world population through health (and death), and who is hellbent to make the Mother Earth a better place through a One World Order. WHO was then “bought” into the UN system.

At that time, Rockefeller with Standard Oil, had also a monopoly on petrol. He decided that pharmaceuticals, up to the 1950’s, mostly based on plants and plant chemistry could be made from petro-chemicals. WHO, according to its bylaws, a disease-preventive health organization, became, thus, largely a curative pharma-based and pharma-pushing organization.

While the bulk of the budget from other UN agencies stems from member countries' contribution, WHO is funded at least to two-thirds or more by the private sector, mostly the pharma industry, as well as the Bill Gates Foundation.

A conflict of interest is more than evident. WHO should not be a UN agency. WHO – against its scientific staff's better knowledge — has declared Covid as a deadly pandemic, spreading fear, imposing lockdowns, face masks, social distancing and more human-denigrating measures.

Eventually, WHO, strongly nudged by the WEF (and the powers behind the WEF) was coercing governments to “vaccinate” their populations with never-before tested genetically-modifying mRNA injections, of which nobody but the producing pharma-industry knows the composition – contents that has turned out deadly for tens of millions of people and mounting.

By the end of 2022, excess mortality in western countries amounts to between 15% and 25% — in some countries even higher.

All of the western used so-called vaccines are, in fact, bioweapons.

This horrendous vaxx fraud is also a multi-billion, if not trillion, bonanza for the pharmaceuticals.

The Covid jabs also contain sterilization agents for both men and women, resulting already by now in drastically falling birth rates in western countries. The term “western countries” means all of Europe and the worldwide *Anglosaxonia*.

So far, all fits well within the Rockefeller, Gates, Soros, *et al's* eugenist agenda.

WHO is truth censoring through social platforms – *NewsGuard*, an organization of “True Journalism”, *tracking* credibility of news and information websites and online misinformation, provides WHO regularly with lists of the most important “influencers” of “misinformation” in matters of health, alias conspiracy theorists; people who do not conform with the official narrative.

WHO forwards this list to the different social media platforms, requesting them to block the accounts of the “perpetrators”, or to clandestinely hide or limit their social media inputs. This is called “shadow banning”.

WHO works closely with the International Fact Checking Network (IFCN) at the Poynter Institute for Media Studies, a non-profit journalism school and research organization in St. Petersburg, Florida. The IFCN has a databank with more than 10,000 “fact-checked false information”, most of them related to WHO dictates.

IFCN is mainly funded by the US State Department, the National Endowment for Democracy (NED), the Bill and Melinda Gates Foundation, Soros Open Society Foundation, Google and Facebook. Coincidentally, the Gates Foundation and the US government are also the biggest donors of WHO.

To top it all off, WHO is currently preparing a so-called *Pandemic Treaty*. Under this Treaty, if approved, WHO's DG would have the power to declare worldwide pandemics as he, alias the ruling class, sees fit to control the masses. *Compulsory vaccinations could be military enforced*. This would be an authority above each of the member countries' National Constitution. So far trial votations have not succeeded, as several country blocks, for example, in Africa, do not agree.

But the beat goes on with coercing and potentially bribing of country delegates. A final vote should take place in the course of 2023. If approved, the lawless Pandemic Treaty rule should enter into effect at the beginning of 2024. If so, this is a call on each WHO member to leave WHO.

3. The North Atlantic Treaty Organization (NATO)

– has long ceased being a defense alliance of North Atlantic countries. It has become a worldwide war machine with access and use of some 850 US military bases around the world.

NATO is not only a multi-billion-dollar income generator largely for the US military industrial complex (MIC), but it is also an important US GDP engine, contributing an estimated 30% of the US GDP, counting all NATO-related and dependent industries and services.

NATO is the provoker, funder and main executer of the Ukraine-Russia war – the US-Russia proxy war. Its expansionism has become a monster octopus, stretching its tentacles completely and all-controlling around Mother Earth.

Other than non-stop provoking Russia, NATO also fulfills a role in the Great Reset / UN Agenda 2030 eugenist agenda, as killing is one of its chief purposes.

China Cements its Position in the Middle East

When Chinese President Xi Jinping arrived in Saudi Arabia on December 7 for his first visit since 2016, he was welcomed with a lavish reception. Fighter jets escorted his plane into Saudi airspace, a purple carpet was rolled out, and cannons were fired. Saudi Arabia's de facto leader, Crown Prince Mohammed bin Salman (MBS), welcomed Xi the next day with a ceremony, during which Xi's car was escorted by members of the Saudi Royal Guard on horseback and carrying the flags of both countries, followed by a welcoming banquet.

The contrast to the low-key reception of US President Joe Biden last July could hardly have been greater. Biden took a longstanding ally, Saudi Arabia, and, by repeating that he would make the kingdom a "pariah nation," created an adversary.

"For an American president to be silent on the issue of human rights is inconsistent with who we are and who I am," Biden said. The same concern for human rights has not seemed to bother him, however, when it comes to China or Iran, whose record on human rights is at least as bad as Saudi Arabia's, if not worse.

China jumped in to fill the vacuum.

Saudi Arabia is now not only one of China's most important suppliers of energy -- a leading American industry that the Biden administration abandoned on day one -- but the kingdom is also an important link in China's Belt and Road Initiative (BRI) -- a gigantic global development project that Chinese President Xi Jinping launched in 2013 to build an economic and infrastructure network connecting Asia with Europe, Africa and beyond. The BRI seeks dramatically to enhance China's

global influence from East Asia to Europe by making countries worldwide increasingly dependent on China. Under the BRI, China has signed cooperation agreements with 20 Arab countries.

China is also Saudi Arabia's largest trading partner -- an arrangement that extends to military cooperation, which China's Minister of National Defense, Wei Fenghe, and Saudi Arabia's Deputy Defense Minister, Khalid bin Salman, agreed to boost in January.

During Xi's visit, furthering the continued expansion and deepening of ties between the two countries, Saudi Arabia and China signed a series of strategic deals, including a "comprehensive strategic partnership agreement" and another with Huawei Technologies on cloud computing, data centers and building high-tech complexes in Saudi cities. The two countries also signed numerous agreements on hydrogen energy, Chinese language education, digital economy, and an "alignment plan" between China's BRI and Saudi Arabia's economic diversification program.

Chinese and Saudi firms additionally signed 34 deals on investment in green energy, information technology, cloud services, transport, construction and other sectors, estimated to be worth around \$30 billion.

In an op-ed published in the Saudi newspaper *Al Riyadh*, Xi described his visit to the kingdom as ushering in "a new era in China's relations with the Arab world, with Arab states of the Gulf, and with Saudi Arabia." He also highlighted the inroads that China made in the Middle East in recent years:

"China has established comprehensive strategic partnership or strategic partnership with 12 Arab states, and signed documents on Belt and Road cooperation with 20 Arab states."

At the end of Xi's visit to Saudi Arabia, he participated in two inaugural summits, which he described as "milestone events in the history of China-Arab relations": the China-Arab summit and the China-Gulf Cooperation Council (GCC) summit.

China's visit to Saudi Arabia and the two summits can be said to represent a culmination, thus far, of China's attempts to take over the Middle East: non-violent means of gaining power over the entire region, as described by Dr. Mordechai Chaziz, author of the book, *China's Middle East Diplomacy: The Belt and Road Strategic Partnership*:

"The connection between the BRI and the strategic partnerships it creates in the region... allows it to gradually take over the region without creating tensions with the U.S. or the West. In other words, the BRI is a sophisticated Chinese plan to transfer hegemony from the West and the U.S. to China without war or conflict."

At the China-GCC Summit on December 9, Xi told Arab Gulf leaders that China would work to buy oil and gas from them and pay in Chinese yuan, a move that China and Saudi Arabia have previously discussed. Such a change could be highly disruptive to the US, especially if it were to be used throughout the Gulf. Using the yuan would considerably bolster China in its ambition to strengthen the yuan while weakening the US dollar's status as the world's reserve currency -- and potentially weakening the US still further internationally. The status of the US dollar depends on its dominance of global markets, especially the oil market, where 80% of sales are conducted in US dollars.

Xi, in his speech to the Arab Gulf leaders at the China-GCC summit, said that in the next three to five years China would work with the Gulf countries on a number of priority areas that would include the following:

All-dimensional energy cooperation, including settling oil and gas trade in yuan; "peaceful use" of nuclear technology, including the establishment of a China-GCC nuclear security demonstration center; finance and investment cooperation, including the setting up of a joint investment commission, a China-GCC forum on industrial and investment cooperation and deepening digital currency cooperation; expanding new areas of cooperation on innovation, science and technology with China setting up big data and cloud computing centers in the Gulf countries, strengthening 5G and 6G technology cooperation and setting up a China-GCC cooperation mechanism in meteorological science and technology; aerospace cooperation, including the possible establishment of a China-GCC joint center for lunar and deep space exploration.

Finally, Xi mentioned China's use of its soft power to increase its influence by "nurturing new highlights in language and cultural cooperation." He said that China will "cooperate" with 300 universities, and middle and primary schools in GCC countries on Chinese language education and work with GCC countries to set up Chinese language learning and testing centers and online Chinese classes. He also suggested a China-GCC language and culture forum, and the compilation of "a bilingual library for people-to-people and cultural exchanges and mutual learning."

At the China-GCC Summit, Xi did not fail to mention the strides that China has made for itself in gaining influence in the Middle East.

"China and Arab states have set an example for South-South cooperation in pursuing mutually beneficial collaboration. The two sides have established 17 cooperation mechanisms under the framework of the China-Arab States Cooperation Forum. Over the past decade, our trade has grown by 100 billion U.S. dollars, with the total volume exceeding 300 billion dollars; China's direct investment in Arab states was up by 2.6 times, with the stock of investment reaching 23 billion dollars; over 200 Belt and Road projects have been carried out, benefiting nearly two billion people of the two sides."

Xi's visit to Saudi Arabia and his meetings with Arab state leaders put on display the influence that China wields in the Middle East, a fact that was not lost on the United States, which has been warning about China's influence in the region.

White House National Security Council spokesman John Kirby said on December 7:

"We are mindful of the influence that China is trying to grow around the world. The Middle East is certainly one of those regions where they want to deepen their level of influence.

"We believe that many of the things they're trying to pursue and the manner in which they're trying to pursue it [sic] are not conducive to preserving the international rules-based order...We are not asking nations to choose between the United States and China, but as the president has said many times, we believe that in this strategic competition the United States is certainly well poised to lead."

"Competition"? Xi has made no secret of his wishes to "replace America as the Global Superpower" economically, militarily, diplomatically and technologically by 2049. The United States might be "well poised to lead," but is it leading? Kirby's warnings, unfortunately, constitute too little, much too late,

A Second Exodus!

Pressure mounts on Christian teams helping Jews make Aliyah.

Apocalyptic scenarios involving war and climate have captured the attention of the media. But rather less focus has been trained on Jewish refugees attempting to flee Russia and Ukraine after nearly a year of gruesome hostilities there.

Also coinciding with a massive increase in worldwide antisemitism, the return to their ancient homeland of Jewish people from the four corners of the world is a key aspect of end-time biblical prophecy (see, for example, Isaiah 11:11f & 49:12, Jeremiah 23:7f & 31:8; Ezekiel 36:24). And Christians are called to help with the process.

For this is what the Sovereign Lord says:

“See, I will beckon to the nations, I will lift up my banner to the peoples; they will bring your sons in their arms, and carry your daughters on their hips.” (Isaiah 49:22)

Since [Russia’s invasion of Ukraine](#) last February 24th, some 70,000 Jewish people have made [Aliyah](#) (i.e. returned to Israel) from the region, mostly from Russia and Ukraine.

But they need help with documents and many other aspects of immigration in order to do so, which has added a huge amount of pressure on the teams working on their behalf. This is where Christian organisations like Ezra International and Ezra UK come in.

As refugees flooded into neighbouring countries in the first month of the war, Ezra’s small Moldova-based team helped almost 2,000 Ukrainian Jews leave for Israel – compare that with the total of 83 immigrants they assisted throughout the previous year.

“Now the numbers are off the scale,” says [Pat Frame](#), who has been helping Jews make [Aliyah](#) for nearly four decades and is now CEO of both aforementioned ministries.

Pat is effectively dealing with a Second Exodus – not this time involving Jews fleeing slavery in Egypt but escaping ongoing persecution all over the world, especially in the former Soviet Union.

Pat left her native Scotland and initially worked in Holland with Bible smuggler [Brother Andrew](#). She first got involved with [Aliyah](#) after reading the book [Exodus II](#) by [Steve Lightle](#) predicting a mass exodus of Jews from Communist countries (which did not, of course, take place until post-1989 following the fall of the Berlin Wall and the subsequent collapse of Soviet society).

“Following a visit to Edinburgh by Steve, one lady started a prayer group for the Soviet Jews and I joined that. It was actually a prayer and action group. We prayed for Refuseniks and believers in prison while also campaigning for them. It eventually took over my life, and I went back to university for an intense one-year course in Russian language – the hardest thing I’ve ever done!”

Ezra focuses on sourcing papers and documents to prove Jewish identity as many are affected by issues around name changes and the destruction of archives. Another emphasis involves helping those struggling financially. For although the wall of communism eventually fell, the wall of poverty often still holds them back. Others need medical help, transport or accommodation. The flights, however, are mostly paid for by Israel’s Jewish Agency.

Although Ezra began operating in Ukraine in 1995, they have since expanded to many other Eastern bloc countries as well as Latin America, Germany and France. They now have representatives in 14 countries, but have assisted with *Aliyah* from at least 30.

“Now we are beginning to deal with more Russian refugees – all on top of our ‘normal’ *Aliyah* work,” Pat adds. “And there are currently long waiting lists for consular appointments. The Ukraine team is also having to deal with power outages along with the sounds and effects of war, while continuing to help as they can with transport to safer places from where they can travel on to Israel.

“It’s a huge challenge and there is great pressure, but this is a time with almost unprecedented opportunities to support our Jewish brothers and sisters in their return ‘home’ to Israel from the biblical *lands of the north*.”
