

# Pfizer tested its 'Booster' on 23 people before Biden's FDA unleashed injections on all Americans; no questions asked



Pharmaceutical giant Pfizer tested its Covid "boosters" on fewer than two dozen people before Joe Biden's Food and Drug Administration approved the mRNA shots for full public use, explosive new documents reveal.

The watchdog group **Judicial Watch** obtained documents through a Freedom of Information Act lawsuit which forced the government to turn over the information.

The organization has published the first batch of those documents and they expose Pfizer's lax testing practices.

According to the documents, Pfizer only tested the safety and efficacy of its Covid vaccine booster on 23 people in 2021 before putting in a request with the FDA to approve the shots for nationwide public use.

Biden's FDA immediately approved the Covid booster shot and pushed it out to the public at the end of September 2021.

The participants included 11 people aged 18 to 55 and 12 people aged 65 to 85, Judicial Watch reported. Of the younger group, there were nine females and two males; eight of whom were white, one was black and two were Asian. Of the older group, six were female, six were males, and all were white.

The FDA said it based **its decision** to approve the shots on the documents presented by Pfizer, as well as input from the CDC, the Israeli Ministry of Health and the University of Bristol in the UK. Based on those paltry numbers of just 23 human guinea pigs and then checking in with the Israelis and a single British university, the FDA gave its rubber stamp and a total of 8.9 million people across America were injected with Covid boosters within three weeks.

Judicial Watch released **58 pages of records** from the FDA showing that a Pfizer "study" administered the shots to just 23 people in 2021 to gauge reactions to its "booster." The FDA indicated that this production of records "represents our complete response to your request; no additional productions are anticipated."

The records were obtained in response to a March 2022 lawsuit filed after the Department of Health and Human Services refused to respond to an August 2021 Freedom of Information Act (FOIA) request. (*Judicial Watch Inc. v. U.S. Department of Health and Human Services* (No. 1:22-cv-00730). The request was for records "submitted by Pfizer and BioNTech to the FDA, including BARDA, relating to 'booster' vaccinations for the SARS-CoV-2 virus."

Biomedical Advanced Research and Development Authority, BARDA, has been heavily involved with the development of the COVID-19 vaccine. According to its **website**:

The Biomedical Advanced Research and Development Authority (BARDA) provides an integrated, systematic approach to the development of the necessary vaccines, drugs, therapies, and diagnostic tools for public health medical emergencies such as chemical, biological, radiological, and nuclear (CBRN) accidents, incidents and attacks; pandemic influenza (PI), and emerging infectious diseases (EID).

These documents are just the latest confirmation of Robert F. Kennedy Jr.'s statement about the safety of "vaccines." None of them are put through the sort of rigorous, double-blind placebo-controlled testing protocols that other medicines are required to go through. And we know that, even with these rigorous testing protocols, there are many examples of medicines that slip through and end up injuring and killing people, forcing companies to pull them from the market.

But with vaccines, none of these rigorous and lengthy testing protocols are followed.

RFK Jr. explains why in the 2-minute video below.

Kennedy explains that vaccines are not considered "medicines" but rather "biologics" which are developed under quasi-military conditions as part of a national defense program against potential biological warfare.

Once Congress created this loophole, corporate pharma companies rushed in to take advantage of a system that allows them to bring vaccines to market very quickly without rigorous pre-licensing safety tests. That's one reason why there are so many vaccines, 72 of them now "recommended" by the CDC as part of the childhood vaccine schedule between birth and age 16. They are extremely profitable and the manufacturers are not accountable for the safety of their products. It's virtually impossible to sue them for wrongful death or serious injury.

"There's not a single vaccine that's ever been tested in a pre-licensing safety study that's part of that 72," said Kennedy.

What kind of nation throws its children to a profit-driven pharmaceutical industry without any safeguards? This is criminal.

But when it comes to the "boosters," this affects not only children but Americans of every age.

A new Covid booster will be released later this month, just in time for a new round of Covid hysteria being cranked up in the mainstream corporate media, which is largely funded by corporate pharmaceutical makers. You just can't make this stuff up, folks.

Judicial Watch President Tom Fitton issued a statement warning the American people to carefully examine the documents his organization has made available before being pressured by the Biden administration to take another booster.

"With the planned push for new boosters by the Biden administration, the public would do well to examine these troubling documents about the shotgun approval of prior COVID boosters," said Fitton.

These documents prove that everything you've heard about "safe and effective" is a smokescreen designed to deceive. All of this talk in the corporate media about "the Covid vaccines are the most rigorously tested vaccines in history," is nothing but lies.

## Biden has a secret, illegal deal with Iran that gives mullahs everything they want

In the latest phase of an unacknowledged and unlawful nuclear deal between the United States and Iran, President Joe Biden this week formally approved giving the world's leading state sponsor of

terrorism another \$6 billion — ostensibly for the release of five Americans held hostage in Tehran.

But in bypassing Congress to avoid a political fight he knows he'd lose, Biden is not only guaranteeing more hostage-taking of American citizens, he's also subsidizing Iran's terrorism, military support for Russia, nuclear-weapons capabilities and repression of Iranian women.

In May, a top White House official visited Oman to pass a message to Tehran: Washington wants to broker a nuclear deal in secret.

Biden would lift sanctions restrictions on Iranian funds held outside its borders, and in exchange Iran would slow its steady march toward a nuclear-weapons threshold.

Iran would be free to continue hunting former Secretary of State Mike Pompeo, former National Security Adviser John Bolton, former Special Envoy for Iran Brian Hook and other Americans.



Tehran could keep directing attacks against Israel through its Hezbollah, Hamas and Islamic Jihad terror proxies.

The mullahs could keep providing armed drones to Vladimir Putin for use against the Ukrainian people.

The regime could even keep producing high-enriched uranium just a stone's throw from weapons-grade, manufacturing advanced centrifuges,

developing longer-range missiles, denying access to international nuclear inspectors and constructing a new underground facility that could prove invulnerable to military action.

Biden's only demands: Don't move across the nuclear threshold by producing weaponsgrade uranium and release five American citizens held hostage in Iran.

For Ayatollah Ali Khamenei, the deal was a dream come true.

On the nuclear front, Iran gives up nothing. The United Nation's nuclear watchdog last week reported that Iran is still expanding its stockpile of high-enriched uranium, just at a slower rate.

As for the five American hostages — at a cost of \$1.2 billion a person — Khamenei will merely restock his collection of American hostages for a future extortion racket.

Meanwhile, Iran gets to use billions of dollars in budget support to subsidize a wide range of illicit activities.

In June and July, the Biden administration unfroze more than \$10 billion of Iranian assets held in Iraq, allowing Baghdad to move payments for Iranian electricity into accounts in Oman established for Tehran's use — payments that will continue on a rolling basis.

Now comes \$6 billion more transferred to accounts in Qatar, providing the regime additional budget support.

Multiple reports also suggest Washington is allowing Tehran to trade \$7 billion in International Monetary Fund special drawing rights for fiat currency.

At the same time, US officials now admit they're allowing Iranian oil exports to China to skyrocket with estimates ranging from 1.4 to 2.2 million barrels per day flowing in August — their highest levels since President Donald Trump ended America's participation in the old Iran nuclear deal.

Conservative estimates put this sanctions relief at \$25 billion in annual revenue. Iran is now eyeing the transfer of another \$3 billion from Japan.

All told, this is at least a \$50 billion protection racket — not just a \$6 billion hostage payment.

How can this occur without Congress holding one hearing or one vote? Because the deal was negotiated in secret and the White House insists there is no deal.

To acknowledge an agreement would trigger a 2015 law, the Iran Nuclear Agreement Review Act, that prohibits sanctions relief for Iran tied to its nuclear activities until Congress has been afforded 30 days to review and potentially reject the deal.

And with job-approval numbers sagging on the eve of his reelection year, waging a political battle over a dangerous nuclear deal is a distraction his aides want to avoid.

Congress shouldn't stand for this flagrant abuse of power and evasion of the law.

Oversight committees should demand all documents related to the secret nuclear negotiations.

The House should also pass a joint resolution of disapproval rejecting the new deal and putting pressure on Senate Majority Leader Chuck Schumer to hold a vote as well.

New legislation to prevent the executive from releasing more money should also be considered.

### Millions Of Brits Told Not To Heat Homes At Night As Part Of 'Net Zero' Climate Goals

Britain's Climate Change Committee (CCC) has urged millions of Britons to not heat their homes in the evening to help the government hit its net zero target.



> No, they aren't urging elites to ditch their private jets for commercial, or not to burn 1,000 of fuel taking the yacht out for

a jaunt. Chris Stark, head of the CCC, wants ordinary citizens to turn off their electric heaters (heat pumps) at night as part of a wider drive to deliver "emissions savings," which includes a shift away from gas boilers - which Chris, a hypocrite, still has.

Contained in a document on "behavior change," the CCC recommended that Britons instead "pre-heat" their houses in the afternoons when electricity use is lower, and would theoretically save families money.

"There is significant potential to deliver emissions savings, just by changing the way we use our homes," reads the CCC's sixth "carbon budget" paper, which lays out how the UK should reduce its emissions between 2033-37.



"Where homes are sufficiently well insulated, it is possible to pre-heat ahead of peak times, enabling access to cheaper tariffs which reflect the reduced costs associated with running networks and producing power during off-peak times."

#### Critics boil

"The grid is already creaking and daft ideas like this show just how much worse it will become," Andrew Montford, the director of Net Zero Watch, told *The Telegraph*. "It's clear that renewables are a disaster in the making. We now need political leaders with the courage to admit it."

And according to Tory MP Craig Mackinlay, head of his party's Net Zero Scrutiny group, "It is becoming clear that adherence to judicable Carbon Budgets and edicts coming from the CCC are developing into farce."

"The Climate Change Act 2008 will require amendment to free us from madcap and impractical targets foisted upon the population by long departed politicians.

"This latest advice to freeze ourselves on cold evenings merely shows the truth that the dream of plentiful and cheap renewable energy is a sham.

"I came into politics to improve all aspects of my constituents' lives, not make them colder and poorer," he told *The Telegraph*.

Lower bills?

The CCC insists that following the advice means "homes will still be warm, but bills can be lowered," adding "This is a demonstration of homeowners benefiting from periods of the day when electricity is cheaper."

"Using electricity to heat a home opens the prospect of choosing a time when prices are lower, something that's not possible with a gas boiler," he continued, adding "Smart heating of homes like this also makes the best possible use of the grid and supports greater use of cheap renewable generation."

The advice follows a furore over Government plans to ban the installation of new oil powered boilers from 2026 and force homes into adopting heat pumps.

Downing Street has hinted it is now set to U-turn amid warnings the move would increase rural fuel poverty and put more strain on the struggling electricity grid.

The CCC is an independent body set up by ministers in 2008 to advise the Government on how to hit its climate targets.

In its latest report, the committee criticises No 10 over its "worryingly slow" action on climate.

It states that Downing Street's support for new oil and coal exploration and the expansion of airports meant Britain was no longer a global green leader. -The Telegraph

Last month Stark, the head of the CCC, admitted that he still has a *gas boiler* at home instead of an electric heat pump (gasp!). And he's not alone.
